### **Please carefully read all information below**

CAPPAs Operation Special Delivery program is a private project consisting of volunteer doulas that provide emotional, physical and informational support during the birth of a baby. CAPPAs Operation Special Delivery program cannot guarantee the placement of a volunteer labor doula for any potential client due to the limited availability of volunteer doulas. However, CAPPAs Operation Special Delivery program will do everything possible to provide a volunteer labor doula for any woman who applies for and is eligible for our services.

The CAPPAs Operation Special Delivery labor doula will meet the client at the scheduled place of delivery as soon as possible after receiving a phone call from the client stating that she is in labor, is being medically induced, or is having a scheduled cesarean birth.

The labor doula will remain with the client throughout the labor and birth, providing comfort measures, reassurance, and doing everything reasonably possible to help the client achieve her personal birth desires. The labor doula will remain with the client for approximately one hour after delivery, and she will contact the client at least once during the postpartum period.

The labor doula will not make decisions for the client. The labor doula will also not perform any medical procedures on the client, including but not limited to, vaginal exams, listening to fetal heart tones, and taking blood pressure. The client agrees to inform her doctor or midwife that she has a professional labor doula. The client also agrees to maintain contact with the doula and to keep her informed of any important information or changes in her status. The client will phone her labor doula at the onset of labor, with the understanding that the labor doula may need as much as two hours time to meet her.

The client understands that the labor doula will make no attempt to obtain compensation for labor doula services as a CAPPAs Operation Special Delivery volunteer doula. The client furthermore understands that there is no guarantee that her labor and birth will occur exactly as she desires. CAPPAs Operation Special Delivery is comprised solely of volunteers with no funding other than donations. CAPPAs Operation Special Delivery volunteer doulas may also accept donations from their Operation Special Delivery clients to help cover their incurred expenses.
